# FEATURES AND PROCEDURES 

## PIRATE'S TREASURE

(Instant Scratch Game \#2236)

1) Theme and name of the game: PIRATE'S TREASURE. Scratch the red "START" square to reveal an arrow. Scratch only the next square in the direction indicated by the arrow to reveal a second arrow. (Refer to the LEGEND on the front of the ticket.) Keep scratching only in the direction indicated by the arrows to reveal the paths through the grid. Note: One of the paths will continue from the center square in the bottom row of the upper grid to the center square in the top row of the lower grid. If a path revealed by following the arrows ends at a prize amount, win that prize.
2) Price of the ticket: Three dollars (\$3.00), or as otherwise set by the Administrator.
3) The prize structure including the number and value of prizes and the odds on each prize are as follows:

Odds and prize statements are based on initial game prize structure and may vary over the life of the game. Entry or non-entry of PIRATE'S TREASURE tickets to the Lottery Super 2nd Chance drawings does not affect the prize structure of the PIRATE'S TREASURE game.
4) The frequency of drawings: There are no drawings in the PIRATE'S TREASURE game, however, for a period of time, at the discretion of the Lottery Division Administrator PIRATE'S TREASURE tickets may count towards entry in Lottery Super 2nd Chance drawings. The Wisconsin Lottery will not be responsible for any neglect, failure or omission on the part of the U.S. Postal Service or any other delivery/courier service used to deliver a player's Super 2nd Chance Drawing mailing to the Wisconsin Lottery. The Lottery assumes no responsibility or liability for Super 2nd Chance tickets that are lost, or destroyed or otherwise disqualified from participation in a drawing when such tickets are in the control of the Lottery. All tickets sent to the Wisconsin Lottery to enter the Super 2nd Chance drawings become property of the Wisconsin Lottery and will not be returned. Only tickets sent to and received at the correct address for entry into the

Super 2nd Chance drawing will be eligible for the Super 2nd Chance drawing.
5) The method of selecting winners: The front of each PIRATE'S TREASURE ticket includes a LEGEND graphic that displays six arrows of different orientations, with each orientation corresponding to a different directional instruction ("go right," "go left," "go BOTH left \& right", "go BOTH up \& down", "go down", or "go up").

There is one (1) play area on the front of each PIRATE'S TREASURE ticket. The play area consists of an upper grid and a lower grid. Along the left edge, right edge, and bottom edge of the play area (both grids) are multiple Exits and multiple prize amounts. Imaged in the uncovered play area are horizontal and vertical solid-line-delineators compiling two (2) grids of squares. In each square, there will be an arrow symbol (having one (1) of the six (6) different orientations as shown in the LEGEND).

The play of the game involves following (scratching to reveal) a predetermined Path, or multiple Paths, through the uncovered play area as follows:
(1) Starting in the "START" play spot (i.e. the upper left corner square of the top grid), move in the direction of the arrow symbol (located in that same uncovered "START" play spot) to the immediately-adjacent arrow symbol. This second arrow's orientation will determine where to move next, as indicated in the LEGEND.
(2) Move to the immediately-adjacent arrow symbol as indicated in the LEGEND.
(3) Continue to move one (1) arrow symbol at a time, using each arrow symbol's orientation to determine where to move next.
(4) If the next immediately-adjacent arrow symbol is either the "go BOTH up \& down" or the "go BOTH left \& right", then the player can play multiple Paths as directed, and the above process is then continued for any new Paths that are created. Each Path is then played separately.
(5) The Path ends if the next immediately-adjacent symbol points the Path directly to an Exit or a prize amount.

The holder of a ticket where a Path ends with an arrow pointing directly at a prize amount (and not an Exit), shall win that corresponding prize amount. A prize may be won for each Path that ends at a prize amount as previously described in the features and procedures.
6) The method of making payment to winners:
A. Submission of the original ticket (not a copy), as provided below, shall be the sole method of claiming a prize.
B. Payment of prizes under six hundred dollars (\$600) may be made by presenting the ticket for validation and payment to any Wisconsin Lottery retailer by the claim deadline under 6(G).
C. The original winning ticket must be signed by a single human being. For-profit and non-profit entities, trusts, and other non-human beings are not eligible to play or claim a prize in this game. Payment of any prize totaling five hundred thousand, nine hundred ninety-nine dollars $(\$ 500,999)$ or less may be made by either 1) signing the back of the original winning ticket, completing a Lottery claim form and presenting it in person to any Lottery office for validation and payment by the claim deadline under section 6(G), or 2 ) by signing the back of the original winning ticket, completing a Lottery claim form and mailing it for validation and payment to Lottery Headquarters in Madison. If claiming a prize by mail, the original winning ticket and Lottery claim form must be mailed to Lottery Headquarters in Madison in a properly addressed envelope with the postage duly prepaid by the claim deadline under section 6(G). Payment of any prize totaling five hundred and one thousand dollars $(\$ 501,000)$ or more must be made by signing the back of the original winning ticket, completing a Lottery claim form and presenting it in person to the Lottery Headquarters in Madison for validation and payment by the claim deadline under section 6(G). Personal appearance may be waived at the Lottery Division Administrator's sole discretion.
D. Tickets are void if stolen, unissued, mutilated, altered, counterfeit, or otherwise fail validation tests. The Lottery at its sole discretion reserves the right to pay any mutilated ticket based upon the facts and circumstances of the particular claim. Such action by the Lottery is final and non-reviewable.
E. Tickets are void if misprinted. "Misprinted" means any mistake or difference from the original ticket or game specifications of any kind in the printing, manufacturing, packaging or other processing related to the production or distribution of the ticket caused by the raw materials, processes or handling of the ticket until its ultimate sale to the consumer/player. "Misprinted" includes but is not limited to the tickets being unreadable, misregistered, defective, or multiply printed. Also, "misprinted" includes errors in the computer software, computer hardware, code or programming of the game regardless of whether the errors were imbedded or caused by human action relating to any of the matters mentioned in this paragraph. The Lottery at its sole discretion reserves the right to pay any such "misprinted" ticket based upon the facts and circumstances of the particular claim. Such action by the Lottery is final and non-reviewable.
F. All tickets sent to the Wisconsin Lottery for the purpose of redemption become property of the Lottery and will not be returned.
G. The holder of a winning PIRATE'S TREASURE ticket must claim the prize, in accordance with sections 6(B) or 6(C), within one hundred eighty (180) calendar days after game's end date or the prize shall be forfeited. If claiming a prize by mail, the postage prepaid envelope containing the original winning ticket and Lottery claim form must be postmarked on or before the one hundred eighty (180) day deadline. The envelope containing the original winning ticket and Lottery claim form must be received by the Wisconsin Lottery Headquarters in Madison within fourteen (14) calendar days after the one hundred eighty (180) day deadline or the prize shall be forfeited.
H. Pursuant to Wisconsin's Open Records law (sec. 19.31-19.39 Wis. Stats.), the Lottery is required to disclose a winner's name, place of residence and, if acquired, likeness. If a player wins and claims a prize, the Lottery may use his or her name, likeness and place of residence without compensation for any purpose. Upon claiming a prize, a winner waives any claims against the Lottery and its representatives for any and all liability which may result from the disclosure or use of such information.
I. Prize payments are subject to the provisions of sec. 565.30 Wis. Stats.
