**FEATURES AND PROCEDURES**  
**GREEN BAY PACKERS**  
(Instant Scratch Game #2366)

- 1) Theme and name of the game: GREEN BAY PACKERS. Match any of YOUR NUMBERS to one of the PACKERS NUMBERS, win corresponding prize. Reveal a "TD" symbol, win DOUBLE the corresponding prize automatically. Reveal a "TROPHY" symbol, win 5 TIMES the corresponding prize!
- 2) Price of the ticket: Ten dollars (\$10.00), or as otherwise set by the Administrator.
- 3) The prize structure including the number and value of prizes and the odds on each prize are as follows:

Odds and prize statements are based on initial game prize structure and may vary over the life of the game. Entry or non-entry of GREEN BAY PACKERS tickets to the Lottery Super 2nd Chance drawings does not affect the prize structure of the GREEN BAY PACKERS game.

- 4) The frequency of drawings: There are no drawings in the GREEN BAY PACKERS game itself; however, at the discretion of the Lottery Division Administrator, Wisconsin Lottery GREEN BAY PACKERS instant scratch tickets may count towards entry in the Packers Bonus Drawing if they are received at the correct address prior to the designated drawing entry deadline. Only tickets received prior to the designated drawing entry deadline at the correct address for entry into the Packers Bonus Drawing will be eligible for the Packers Bonus Drawing. For a period of time, at the discretion of the Lottery Division Administrator, Wisconsin Lottery GREEN BAY PACKERS instant scratch tickets may be entered into the Lottery Super 2nd Chance drawings. The Super 2nd Chance Drawing is a separate drawing from the Packers Bonus Drawing. Due to the nature of the Packers Bonus Drawing and the Super 2nd Chance drawings, a single GREEN BAY PACKERS instant scratch ticket may only be used to enter into one drawing and cannot be used to enter into both drawings.

All tickets sent to the Wisconsin Lottery's Packers Bonus Drawing address become property of the Wisconsin Lottery and will not be returned. Only tickets sent to and

received at the correct address for entry into the Packers Bonus Drawing will be eligible for the Packers Bonus Drawing. Any GREEN BAY PACKERS instant scratch ticket entered in the Packers Bonus Drawing will be ineligible for any prize for which it would otherwise have entitled the holder. Any such ticket entered into the Packers Bonus Drawing will be considered a non-winning ticket for the purposes of eligibility to qualify for the Packers Bonus drawing.

All tickets sent to the Wisconsin Lottery's Super 2<sup>nd</sup> Chance drawing address become property of the Wisconsin Lottery and will not be returned. Only tickets sent to and received at the correct address for entry into the Super 2<sup>nd</sup> Chance drawing will be eligible for the Super 2<sup>nd</sup> Chance drawing.

The Wisconsin Lottery will not be responsible for any neglect, failure or omission on the part of the U.S. Postal Service or any other delivery/courier service used to deliver a player's Packers Bonus Drawing or Super 2<sup>nd</sup> Chance Drawing mailing to the Wisconsin Lottery. The Lottery assumes no responsibility or liability for Packers Bonus Drawing tickets or Super 2<sup>nd</sup> Chance tickets that are lost, destroyed or otherwise disqualified from participation in a drawing.

- 5) The method of selecting winners: The holder of a ticket showing a number in any of the twenty (20) uncovered YOUR NUMBERS play spots that matches one (1) of the five (5) numbers in the uncovered PACKERS NUMBERS play area shall win the corresponding prize amount shown for that same matching YOUR NUMBERS play spot. The holder of a ticket showing a "TD" play symbol in any of the twenty (20) uncovered YOUR NUMBERS play spots shall win two (2) times the corresponding prize amount shown for that same play spot automatically regardless of the numbers in the PACKERS NUMBERS play area. The holder of a ticket showing a "TROPHY" play symbol in any of the twenty (20) uncovered YOUR NUMBERS play spots shall win five (5) times the corresponding prize amount shown for that same play spot automatically regardless of the numbers in the PACKERS NUMBERS play area.
- 6) The method of making payment to winners:
  - A. Submission of the original ticket (not a copy), as provided below, shall be the sole method of claiming a prize.
  - B. Payment of prizes under six hundred dollars (\$600) may be made by presenting the ticket for validation and payment to any Wisconsin Lottery retailer by the claim deadline under 6(G).
  - C. The original winning ticket must be signed by a single human being. For-profit and non-profit entities, trusts, and other non-human beings are not eligible to play or claim a prize in this game. Payment of any prize totaling six hundred dollars (\$600) or more requires the claimant to provide his or her Social Security number, his or her Individual Taxpayer Identification Number, or a properly completed IRS Form W-8BEN (i.e. a Certificate of Foreign Status of Beneficial Owner for United States Tax Withholding and Reporting). Payment of any prize totaling one hundred ninety-nine thousand, nine hundred ninety-nine dollars (\$199,999) or less may be made by either 1) signing the back of the original

winning ticket, completing a Lottery claim form and presenting it in person to any Lottery office for validation and payment by the claim deadline under section 6(G), or 2) by signing the back of the original winning ticket, completing a Lottery claim form and mailing it for validation and payment to Lottery Headquarters in Madison. If claiming a prize by mail, the original winning ticket and Lottery claim form must be mailed to Lottery Headquarters in Madison in a properly addressed envelope with the postage duly prepaid by the claim deadline under section 6(G). Payment of any prize totaling two hundred thousand dollars (\$200,000) or more must be made by signing the back of the original winning ticket, completing a Lottery claim form and presenting it in person to the Lottery Headquarters in Madison for validation and payment by the claim deadline under section 6(G). Personal appearance at the Lottery headquarters in Madison may be waived at the Lottery Division Administrator's sole discretion.

- D. Tickets are void if stolen, unissued, mutilated, altered, counterfeit, or otherwise fail validation tests. The Lottery at its sole discretion reserves the right to pay any mutilated ticket based upon the facts and circumstances of the particular claim. Such action by the Lottery is final and non-reviewable.
- E. Tickets are void if misprinted. "Misprinted" means any mistake or difference from the original ticket or game specifications of any kind in the printing, manufacturing, packaging or other processing related to the production or distribution of the ticket caused by the raw materials, processes or handling of the ticket until its ultimate sale to the consumer/player. "Misprinted" includes but is not limited to the tickets being unreadable, misregistered, defective, or multiply printed. Also, "misprinted" includes errors in the computer software, computer hardware, code or programming of the game regardless of whether the errors were imbedded or caused by human action relating to any of the matters mentioned in this paragraph. The Lottery at its sole discretion reserves the right to pay any such "misprinted" ticket based upon the facts and circumstances of the particular claim. Such action by the Lottery is final and non-reviewable.
- F. All tickets sent to the Wisconsin Lottery for the purpose of redemption become property of the Lottery and will not be returned.
- G. The holder of a winning GREEN BAY PACKERS ticket must claim the prize, in accordance with sections 6(B) or 6(C), within one hundred eighty (180) calendar days after game's end date or the prize shall be forfeited. If claiming a prize by mail, the postage prepaid envelope containing the original winning ticket and Lottery claim form must be postmarked on or before the one hundred eighty (180) day deadline. The envelope containing the original winning ticket and Lottery claim form must be received by the Wisconsin Lottery Headquarters in Madison within fourteen (14) calendar days after the one hundred eighty (180) day deadline or the prize shall be forfeited. In the event that the Governor declares a state-wide emergency or similar unforeseen circumstance occurs, the one hundred eighty (180) day deadline may be extended in the sole discretion of the Wisconsin Lottery Division Administrator.

- H. Pursuant to Wisconsin's Open Records law (sec. 19.31-19.39 Wis. Stats.), the Lottery is required to disclose a winner's name, place of residence and, if acquired, likeness. If a player wins and claims a prize, the Lottery may use his or her name, likeness and place of residence without compensation for any purpose. Upon claiming a prize, a winner waives any claims against the Lottery and its representatives for any and all liability which may result from the disclosure or use of such information.
- I. Prize payments are subject to the provisions of sec. 565.30 Wis. Stats.
